


## Project Scope


- The project consists of improvements to I-66 from approximately Haycock Rd. to Westmoreland St.
- Improvements include:
  - Widening of 2 Bridges
    - *Williamsburg Blvd.*
    - *Westmoreland St.,*
  - Sound Wall Construction
  - Median Barriers and Curb and Gutter
  - Full Depth Shoulder Construction
  - Drainage Improvements


## Design Features

- **12 Foot Auxiliary Lane on I-66 WB**
- **Reconstruction of Median and Outside Shoulders**
- **Widening of Existing Bridges over Williamsburg Blvd. and Westmoreland St.**
- **Sound Walls at Designated Locations**










**Typical Section**

# Issues Related to Night Work

- **Safety of the Traveling Public**
- **Noise and Air Pollution**
- **Timely Removal of Lane Closures**
- **Emergency Contact & Response Time**

# Tow Wrecker Service

- **Contractor must provide tow wrecker service for maintenance of traffic during all lane closures.**
- **“The wrecker shall be available to move into its designated location in the work zone prior to any lane closure and shall remain in that location in a state of full readiness until the work zone is removed.”**

## Interim Contract Milestones

- **July 9, 2015 – Substantial Completion**
  - Final traffic configuration in place with Surface Asphalt installed through project.
  - Installation of all other contract items including roadway lighting, signage, and ITS.
- **August 7, 2015 – Final Contract Completion**
  - Completion of all contract items including Surface Asphalt, Final Pavement Markings, and approval of completion of all punch list work.
